Kiwanis Scholarship Fund

For many years Kiwanis has sponsored five \$1,000 scholarships for Southeastern Community College students. The scholarships have been greatly appreciated by recipients, and represent a big chunk of a year's tuition costs.

Rich Goughnour oversaw the growth of our Scholarship Endowment Fund for about 13 years, and it recently passed the \$100,000 mark. Besides donations and memorials, the Club also contributes money on the passing of a member.

On a recommendation from the Investment Committee, it was recently voted to partner with the Community Foundation of Des Moines County to make contributions eligible for a 25% Iowa Tax Credit. Using a small amount of money from

the fund and a generous donation from President Dennis Wilson, an account was opened with the Community Foundation. Any donations to the Scholarship Fund now qualify for the 25% Tax Credit. For example, a member contributing \$200 to the fund would be able to take \$50 off their 2012 Iowa taxes next year. A \$1,000 contribution would qualify for a \$250 tax reduction. This is of course in addition to the charitable deduction on your federal return.

Please keep this fund in mind as you consider your yearly charitable giving. And if you know of someone who has suffered a death in their family and is looking for an effective memorial, the Kiwanis Scholarship Endowment would be a great choice.
